How to Register to the Equine Therapy Registry (ETR)

Registering on ETR is your first step to take direct control of your listing.

If you would rather have us update your listing, whenever you want to make a change, you are still invited to register but it is not compulsory.

Please read this before moving forward:

Step 1: After clicking on the "Register Now" link at the bottom of this page, the Registration Form will appear (shown below). You need to fill out only the top portion, titled *User Registration*.

All information in the *User Profile* section is optional at this point; you will have the opportunity to update your profile later on, as part of your listing.

When done filling out the top portion scroll down to the bottom of that page and click on

Step 2: The following screen will tell you a confirmation email was sent to you.

Your account has been created and an activation link has been sent to the email address you entered. Note that you must activate the account by selecting the activation link when you get the email before you can login.

Step 3: After opening the confirmation email and clicking on the activation link, you will be directed to this confirmation screen:



Step 4: Now log in using the Username and Password you entered upon registration. The next page coming up will probably be your Dashboard. Whether it is or not, your next step is to Claim your Listing, so please go back to the "Claim Listing" tab on the navigation bar and continue with Step 2.

Step 5: Once you claimed your listing you can go back to your Dashboard to edit, add or even deactivate your listing if needed. There you can also add images, videos, special offers for your visitors and you can also list future events happening at your facilities.

How to CLAIM A LISTING

In order for a owner or manager to be able to directly manage the information they want the general public to have access to, the listing must first be claimed by the authorized person.


The process is simple (you may want to print this page to follow along while doing it):

Step 1: Register. If not already done, please register before going any further. Click here: Register				
Step 2: Once registered, find your listing one of two ways, under the "Registry tab" on the navigation bar: A: select "Search" and enter one or two words that are part of your business name, or B: select "All Listings" and locate your business there. Click on the link to access the information already gathered from public domain. You may be asked to log in if not already done.				
Step 3: On the right side of your listing you will see this button does not appear it means that your listing has already been claimed. If it has already been claimed without authorization please contact us immediately so we can investigate.				
Step 4 : Depending on your registration and when or from which computer you registered, you may now be seeing this screen, or the one in Step 5 below:

If you have not yet registered, you can do it from that screen by clicking on "Don't have an account?" at

the bottom.

Step 5: On the "Claim Listing/Business" page, enter the requested information to validate your claim. Note that you must enter text in all fields; in the "Function" field, if not sure enter "self", "Rep", or something else you will recognize. Once you have claimed your listing, the request is reviewed ASAP by the Registry Administrator; depending on the day and time, approval normally takes a few minutes, but it could several hours. Please realize that each claim is individually processed to ensure protection of the information. You will receive a confirmation email, and you can then return to your listing and edit any of the information you want. Make sure to save your changes. Remember that anything you enter in your profile will be viewed by visitors.



You should now see the image below.

If you do not see the following confirmation try your claim one more time. If still no confirmation, please contact us for support.



Once your listing is claimed and you received the email confirmation (see above), you can now go back to it anytime you want, through the "Dashboard" tab, to add or delete information, make improvements, or make any change you want.

How to EDIT A LISTING

In order to edit and make changes, you must be REGISTERED and you must have CLAIMED YOUR LISTING.

If not done yet, please take a moment to: REGISTER and CLAIM LISTING

To make changes follow this simple process (you may want to print this page to follow along while doing it):


Step 1: Go to Dashboard and select "Log in" - this will redirect you to your own dashboard.

If not already logged on, the following screen will come up - simply enter the UserName and Password you elected when you first registered.



After clicking Edit the page with all your listing's information will come up and you can now edit at will.


Make sure to save your changes.

How to ADD A LISTING

PLEASE DO NOT ADD A DUPLICATE LISTING

Before adding a listing please make sure it is not already there. Search the registry and if you find your entity there please select **Claim Listing** on the navigation bar.

To add a new listing, please follow these steps (you may want to print this page to follow along).


See "Step 5" below for the criteria.

Step 1: If not already registered, please <u>REGISTER</u> now and then come back here to continue.

Step 2: Log in to the platform. The quickest way is to go to the DASHBOARD tab and select "Log in"

Step 3: After logging in, you should be automatically redirected to your Dashboard (see sample below). This is where you control your listing(s). Select "Business Listings" and on the next page select

the New button.





Step 4: Fill out the form to the best of your knowledge. The fields with a green asterisk * must be entered.

If you don't yet have a website, enter the web address where visitors could get information, like your Facebook page for example.

If you have absolutely no web address to enter, then please enter www.EquineTherapy.online for now.

You can change this anytime.

You will see the option of adding a tab: this relates to the tabs on your listing (we suggest you view your listing and then decide if you want to add a tab).

There might be fields that are not relevant to your entity: leave them blank. (Please note that the "Bookmarks" section is not in operation at the present time)

Make sure to click **SAVE** before leaving that page or before taking a break from your computer/tablet/phone to avoid the Form to time out.

Step 5: All your information is saved on the database the moment you click the "Save" button.

Now your new listing will be reviewed to ensure it meets certain basic criteria:

- authorized and true information
- legal and moral equine-assisted therapy related activities
- no criminal records
- no unresolved complaints
- you do what you claim you do

Your listing will be automatically updated to the proper status once reviewed.

You can now go back to your Dashboard any time and edit your listing at will, add special offers or future events you would like visitors to see, etc.
